

Nomination Steven Rebellato - Hedgerow Software Ltd. Award for Leadership in Environmental Health

Please accept my nomination for Dr. Steven Rebellato (Steve) for the Hedgerow Software Ltd. Award for Leadership in Environmental Health. Steve is a confident and charismatic leader, he is knowledgeable, he is experienced, and is a dedicated public health professional. He is consistently demonstrating outstanding leadership qualities.

Steve has a strong public health and health services background; he is a Certified Public Health Inspector (2002) and holds a Ph.D. in Public Health and Health Systems (Health Studies and Gerontology) from the University of Waterloo. Steve is currently the Vice President, Public Health (Environmental Health Department) for the Simcoe Muskoka District Health Unit, in Ontario. In this role, Steve has a consistent track record of displaying his commitment to both public health and the agency.

Steve also works at the University of Waterloo and McMaster Universities in the school of public health. He volunteers York Hills Child and Family Centres for Children, Youth and Family Mental Health and Well-Being as a board member.
