**CIPHI STUDENT MEMBERS  
CONFERENCE SPONSORSHIP ANNOUNCEMENT  
JULY 18, 2019**

The Board of Trustees of the Environmental Health Foundation of Canada (EHFC), the Charitable Division of CIPHI is pleased to announce the approval of \$5,000 to support Student CIPHI Members to attend the forthcoming CIPHI Annual Educational Conference being held in Halifax, Nova Scotia, Sept. 8-11, 2019.

The application criteria is as follows:

- Applicants must be enrolled in their final year or a 2019 graduate from one of the six educational institutions accredited by the CIPHI Board of Certification (**proof will be required**).
- Applicants must be a 2019 Student Member of CIPHI as listed on the CIPHI website by province and membership type ([www.ciphi.ca/membership-list/](http://www.ciphi.ca/membership-list/)).
- Applicants are responsible for the cost of any necessary travel and/or accommodations to facilitate their attendance at the conference. Additional information can be found at [www.ciphi.ca/aec2019/](http://www.ciphi.ca/aec2019/)
- The EHFC Board will cover the cost of the conference “early bird” student registration fees as follows:  
Full **\$450 + 15% HST = \$517.50** OR  
One Day **\$299 & 15% HST = \$343.85**
- The EHFC will pay the student registration directly to the conference committee. However, if the student fails to attend the conference or does not cancel by **August 31<sup>st</sup>** (to allow for another student to fill their vacancy) the EHFC will expect the individual to reimburse the EHFC for the approved funding.
- Financial support will be approved on a **first come-first serve basis** upon meeting the required criteria and while funds are available. All applicants will be notified via email on **August 9, 2019**, if they are to have the cost of their registration covered by the EHFC.
- Upon completion of the conference, sponsored students are requested to provide a minimum of 500-word report to the EHFC outlining the benefits of having attended the conference by **October 8, 2019**.
- The total funds available for this 2019 funding shall not exceed \$5,000 as approved by EHFC Board Motion.
- Requests are to be via email providing the following information in the body of the email and directed to [EHFC@outlook.com](mailto:EHFC@outlook.com) no later than **August 2<sup>nd</sup>**.
