



### **AWARDS**

#### Canadian Water and Wastewater Association Water Safety Award:

This award in recognition of outstanding contributions to the promotion of drinking or recreational water safety in Canada. A \$500 award and certificate will be presented annually to a CIPHI (regular) member. Applicants must be working in the environmental public health field and a CIPHI member in good standing for five (5) consecutive years.

#### **EHFC Continuing Education Award:**

A \$500 award and certificate is presented annually to a CIPHI (regular) member. Applicants must be working in the environmental public health field and a CIPHI member in good standing for five (5) consecutive years. The applicant may be enrolled in a single course or a program.

#### Len Hiebert Environmental Health Review Award:

A \$250 award and certificate is presented to a student or team of students conducting a research project in each of the five accredited public health inspection programs in Canada

#### Lilli Ann Zahara Award:

A \$500 award and certificate is presented annually to a CIPHI (regular) member. Applicants must be working in the environmental public health field and a CIPHI member in good standing for five (5) consecutive years. The recipient shall display the highest level of dedication, commitment, inspiration and leadership in the field of environmental health, particularly with a focus on food safety and/or health education.

#### National Sanitation Foundation International Food Safety Award:

A \$1,000 award and certificate is presented annually to a CIPHI (regular) member in recognition of outstanding contributions to the promotion of food safety in Canada. Applicants must be working in the environmental public health field and a CIPHI member in good standing for five (5) consecutive years.

# CANADIAN WATER & WASTEWATER ASSOCIATION SAFE WATER AWARD

**Glen Hudgin, CPHI(C), Environmental Health Manager, Niagara Region Public Health, Ontario** was nominated by his Director Bjorn Christensen in recognition of his work on predictive modeling for bathing beaches. Below is the nomination letter submitted.

In recent years, public health officials throughout Ontario have been concerned that the actual E. coli populations found during beach water testing may have changed substantially on the days of posting or un-posting (usually 48 hours later). In 2008, Glen led a study of two popular Niagara beaches which found that it was not unusual for these beaches to be posted although, in fact, the water quality was within the acceptable standard and the beach could have remained open and equally there were times when beaches were open but should have been posted because the acceptable standard was exceeded. Further studies conducted in 2009 and 2010 provided more evidence of deficiencies in the widely used Persistence Model protocol.

Extensive research and discussions with agencies such as Environment Canada, Ministry of Environment, Environmental Protection Agency, Great Lakes Beach Association, International Joint Commission, Remedial Action Plan, Great Lakes and St. Lawrence Cities Initiative, Blue Flag and the Canadian Centre for Inland Waters identified Predictive Modeling as the most promising alternative. Predictive models, developed through statistical techniques such as multiple linear regression, use easily measured environmental and water-quality variables to estimate bacterial-indicator concentrations. The data sources which are utilized include but are not limited to, water temperatures, climate or meteorological data, historic water data precipitation, wind speed and direction, stream flow, wave height, turbidity and physical site assessments and the integration of these data sources provides an accurate probability, in real-time, of whether or not the designated bacterial standard will be exceeded.

Building on these partnerships, along with using his powers of persuasion, Glen was eventually able to secure funding from a variety of agencies at the Federal, Provincial and local level to moor buoys, equipped with monitoring instrumentation and wireless capabilities, in three selected bathing areas in the Niagara Region. Bathing water samples continue to be collected daily from these beaches using the traditional (persistence model) process and early analysis demonstrates that a correlation is being identified between elevated E.coli counts and specific climatic and/or environmental factors. It is expected that the eventual outcome for Niagara Region Public Health will be development of a decision support tool for determining the bacteriological status of recreational water in real-time. This initiative is providing more accurate and more temporal information to users of bathing beaches in Niagara Region and consequently, reducing the potential for water-borne disease in the area.

It is felt that the success of this project will be ground breaking in Ontario as other Health Departments are taking notice of the work being done in Niagara looking at beaches through a eco-system/watershed model as opposed to just the individual component of a beach. This project would not have come to fruition without the leadership, tenacity and forward thinking of Glen Hudgin.



# CONTINUING EDUCATION AWARD

Below is Marina's application letter:

**Education – a Builder of Skills, Capacities and Motivation:** As a part-time graduate student at the University of Waterloo in the Masters of Environment and Business (MEB) program, with a focus on social, environmental and economic sustainability, I'm learning and applying many aspects of course content to my current Manager's position. In addition, to expanding my scope of practice and increasing my professional skills, the demands of learning have re-engaged my thinking styles and motivation.

In terms of my scope of practice, the participants in the MEB program bring a vast array of experience and background to the course, particularly related to private enterprise. Environmental health professionals are generally well versed in the concepts of environmental and social sustainability, however are rarely exposed to aspects of economic sustainability. This course provided the context and language to enable me to discuss and engage with partners related to economic sustainability as well as environmental and social sustainability. I believe this adds credibility to our profession and to our respective agencies when engaging with stakeholders around sustainability issues.

In terms of professional skills, education has also enhanced my core competencies, particularly related to surveillance, assessment and health promotion. Surveillance and assessment skills are needed in preparing research proposals, determining data collection methodology, developing indicators and completing project evaluation. In addition, this course reinforced the critical importance of surveillance and monitoring systems at the local, national and international levels. In terms of health promotion, as this course included a private sector perspective, I have benefited from a deeper understanding of marketing and promotion strategies. It was interesting to view policy development and advocacy options from both a public and private perspectives. In addition, there was a consistent emphasis on the importance of authentic stakeholder engagement. This was supported with the application of best practices for partnerships and stakeholder engagement to a public health related project. Other areas of expertise have been enhanced for me such as strategy development, business and agency operations, human resource development, communication and finance. These areas of expertise are underpinned with key foundational values based on accountability, transparency and continuous improvement.

Further education provides the opportunity to re-engage learning processes. As it had be many years since I was a student, it was challenging, at times, to develop learning pathways. Critical and analytical thinking, communication skills and thoughtful reflection were all needed in order to progress in a learning environment. In addition, there was an emphasis on bringing a systems-thinking approach to issues. Systems thinking is a crucial skill for public health inspectors as we operate in multi-jurisdictional systems with a wide array of individuals, stakeholders and professions and need to be competent with regulatory and health promotional approaches.

Finally, further education re-ignited my passion for learning and my pride in my profession. The educational forum provided me with an opportunity to promote public health inspectors to other professions. By engaging in this course, I was constantly reminded of the value, need and importance of public health inspectors and this continues to motivate and inspire me.



### LILLI ANN ZAHARA AWARD



**Virginia MacEachern, CPHI(C), Algoma Public Health, Ontario** was nominated by her colleague Jennifer Francella. Below is the nomination letter submitted.

Virginia has been a regular member of CIPHI since receiving her Certificate in Public Health Inspection in 2008. Virginia has worked as a full-time Public Health Inspector with Algoma Public Health since 2008. In addition to her inspection duties, Virginia has embraced the role of the lead inspector for the food safety program at Algoma Public Health.

In her time as the lead of the food safety program, Virginia has revised and updated our safe food handler's course and put into place a standardized training program that has created a substantial increase in food handler training in the district of Algoma. Prior to her involvement, the safe food handler's course was taught by instructors at Sault College of Applied Arts and Technology. Our course is now taught by Health Inspectors with Algoma Public Health. We have watched with pride as our community has come to recognize the value of this training and we now have waiting lists for our courses which are held routinely throughout the year. In the past three months alone, Algoma Public Health has certified over 230 food handlers.

Virginia displayed further dedication and leadership in the food inspection program in 2012 when she identified improper safe food handling practices by culinary arts students at Sault College. Rather than simply documenting and correcting the infractions on an inspection by inspection basis, she embarked on a research project to examine and evaluate the effectiveness of hands on safe food handling training for food handlers versus classroom based learning and its outcome on infractions noted during the routine inspection process. Her research has resulted in an enhanced relationship with staff and students in the culinary arts program.

Her dedication and professionalism has been recognized by others in the community. In 2013, Virginia was asked by Sault College to be a member of the advisory council for the Hospitality and Culinary Arts Committee. Her involvement on the committee will give Algoma Public Health the opportunity to ensure that food safety remains a key component of the chef training program.

Her colleagues have watched with pride as she endeavoured to make safe food handler training more accessible to the residents in our District and improve the postsecondary training available in our community.

I believe she is a perfect example of a Public Health Inspector that is dedicated and committed to the profession and whose leadership has positively changed a community.



# NSF INTERNATIONAL FOOD SAFETY AWARD

The NSF generously donates \$1,000 per year for this Food Safety award. Given that there were a number of worthy nominations in 2014 the EHFC Trustees agreed to award two public health inspectors with this award since there were no nominations in 2013.

I believe Nyall Hislop is an excellent candidate for the NSF International Food Safety Award. Myall has worked in Edmonton as an EHO for the past 17 years and has worked his way from a field inspector in Edmonton's inner city to the position of Senior Advisor, Safe Food, Edmonton, Alberta Health Services.

Nyall has been actively involved in a number of food safety initiatives over the years:

- Extensive experience working on local, provincial and federal committees. He was a member of the Federal/ Provincial/Territorial Committee on Food Safety Policy—Donair Working Group. Member of the Food Expert Advisory Committee established by the Food Directorate, Health Canada in 2010 and is presently serving his 2nd term. Member of the Alberta Health Services (AHS) Safe Food Committee and is chair of the AHS Food Industry Advisory Team sub-committee of Alberta Health's Food Regulation and Food Retail and Foodservices Regulatory Advisory Committee.
- Has published in several Journals including the Journal of Environmental Health, Environmental Health Review,
  Canada Communicable Disease Report and the Canadian Journal of Public Health. (CJPH) His most recent
  publication in the CJPH entitled "Food Safety Retention Study" was based on field research he designed and
  coordinated from Safe Food—Edmonton data. The study demonstration food handlers without formal food safety
  training and either less than one years experience or greater than 10 years were most likely to fail a standardized
  food safety test. Nyall received the E.H.R. award for this research.
- Actively involved in the research and development of new standards and guidelines for AHS. His "Microbial Guidelines" for ready-to-eat foods was published in the E.H.R., and has been adopted for use through out AHS and other health agencies in Canada and the US. Redesigned and updated the Suspected Foodborne Illness questionnaire used by AHS provincially to interview cases.
- Presented at numerous CIPHI conferences as well as the University of Alberta School of Public Health and the Alberta Health association. Adjunct Professor at Edmonton's Concordia University College for the After-Degree Program in Environmental Health.

It is with great pleasure to nominate Mrs. Cynthia Peacock-Rocca for consideration for the 2014 NSF award in recognition of her outstanding dedication, inspiration and her timeless efforts in promoting food safety in our community. Cynthia has been a certified PHI for over 10 years. In 2003, she started her career with the Sudbury & District Health Unit as a PHI. She was promoted to the position of an Environmental Support Officer and recently she became the Acting Food Safety Manager.

Cynthia was the councillor on the CIPHI Ontario Branch Food Safety Committee for four years. The goal of this committee is to act as the provincial food safety liaison with reginal food safety committees and other food safety stakeholders. Part of her role included reviewing and updating food safety division resources, promoting the distribution of food safety resources. She participated on the Ontario Multi-Agency Foodborne Outbreak/Food Recall working group. The purpose of this group was to improve the effectiveness of multi-agency responses to foodborne outbreaks/food recalls in Ontario. During her term on this committee such she also recruited PHIs to represent the CIPHI Ontario Branch on Food Safety sub-committees such as the Guelph Food Safety Seminar Series Committee.

Currently, she is the Acting Food Safety Manager at the Sudbury & District Health Unit. Cindy provides excellent leadership and support to her colleagues through positive encouragement of food safety resource development such as updating the Special Event Food Permit package, the creation of a food safety calendar, and the development of an information package for new food establishment operators.

Because of her commitment in the field of environmental health with a focus on food safety, she has earned the respect and support of her colleagues. Cynthia is an inspiration and a mentor to both new and current divisional employees through her knowledge of food safety. We are grateful to have such a well-rounded leader.

#### NCCEH STUDENT PROJECT AWARD

This student project is an annual award offered by the National Collaborating Centre for Environmental Health (NCCEH) in partnership with the Environmental Health Foundation of Canada (EHFC) for students enrolled in Canadian post-secondary institutions offering a Public Health Inspection program or a degree in public health. 
# EHFC PARTICIPATES IN THE DEVELOPMENT OF THE CIPHI STRATEGIC DIRECTION WORK PLAN

In June of 2013 members of the National Executive Council, Board of Certification, Environmental Health Foundation of Canada and the Council of Professional Experience gathered in Winnipeg to develop a strategic plan for CIPHI. This marked the first time in CIPHI's history that all of the governing bodies of CIPHI met to develop Strategic directions for the institute.. Several key strategies were identified and validated during the session in June and results of this meeting were compiled in a strategic plan, each with identified initiatives. Throughout the fall of 2013 the NEC identified the need to meet again to keep the momentum going by developing a detailed work plan and identifying leadership and accountabilities for each of our strategies and corresponding initiatives that had been identified as priorities.

- deepen our understanding of our roles and responsibilities in fulfilling the business requirements of CIPHI.
