EHFC Eighth Annual Report

Canadian Institute of Public Health Inspectors

Annual General Meeting **April 29, 1997**

On behalf of the Environmental Health Foundation of Canada (E.H.F.C.) I am pleased to present this report to the members of the C.I.P.H.I. The 8th annual meeting of the Foundation was held on **July 2, 1996** during the C.I.P.H.I. conference in **Chicago.**

Since the last AGM the Board of Trustees regretfully accepted the resignation of Mr. Dean Sargeant as Secretary of the Foundation. Dean is one of the founding members of the Foundation which was inaugurated in 1989. Over the last few years three other founding members (Mr. Doug Terry, Mr. Tom Gable, and Dr. Franklin White) have officially resigned from the Board. During one of our tele-conference meetings approval was given by the Board of Trustees to honour the contribution and time given to the Foundation by those who have left the Board by issuing a recognition award.

I am pleased to announce our newly appointed members since the last AGM. Mr. Keith Smith, a public health inspector from Saskatchewan, Mr. Pat Murray, a public health inspector from Newfoundland and also the Branch President representative of the C.I.P.H.I. and; Mr. Bryan Walton, an industry representative from the Canadian Council of Grocery Distributors.

A summary of the progress of activities of the EHFC since the last annual report follows.

Food Safety Temperature Symbols

There were no objections to our proposed temperature symbols advertised in the trademarks journal. This allowed us to proceed to the final stage to have our symbol trademarks become official. We have one year to develop and implement prototypes of the symbols as part of an education programme.

The public awareness programme on what the food safety temperature symbols mean will not only increase awareness, but also raise the profile of our profession. Aboriginal Student Sponsorship—Environmental Health Programme

Since the Foundation's first major project has concluded successfully, the Foundation is exploring different strategies to continue in sponsoring aboriginal students or programmes. Keith Smith, is now a CPHI (C) and has been appointed as a Trustee on the Foundation Board. Keith is now directly involved in this project, from a different perspective, to determine which directions we should be taking. He has been promoting our profession and the Foundation at some of the First Nation's secondary and post secondary schools. Participation by funding sponsorship, the development or implementing different strategies is welcome and greatly appreciated.

"Septic System Maintenance Pure & Simple" Video and Education Programme

The Foundation acquired the copyrights for a video educational package from the Central Fraser Valley Union Board of Health for distribution across Canada. Our vice-Chair Tim Roark and Treasurer Charlie Young were instrumental in the development of the package. The C.I.P.H.I. NEC as a partner has also agreed to participate in the promotion and distribution of this excellent programme. The package includes the video, a pamphlet which provides advice, in easy to understand language, how to maintain a private sewage disposal system; a large poster for promotional purposes; and transparencies accompany the video to enhance any presentation which is given to various groups. The components of this package are applicable for the home owner, and agencies who work in the programme and wish to provide seminars on the subject.

In the video, TV personality John Barton takes viewers through the inner workings of a conventional septic tank and gravity flow tile bed. Mr. Barton discusses basic maintenance activities to prevent problems; what can go wrong and what tell tale signs to look for if regular maintenance does not occur.

EHFC WEB Page

The Foundation Board of Trustees approved a motion to participate in the C.I.P.H.I. initiative in developing an Institute WEB page on the internet. The EHFC will be a link to the main page and will include descriptions of the Foundation; our projects and how to participate, and links to other environmental health links. It is our expectation that with a more 'worldly exposure' the Foundation's projects and activities will receive continued support in both a financial and participatory form.

Bob Herbison Bursary

Donations to the *Bob Herbison Bursary* continue to be received. Recently the Chief EHOs in B.C. contributed approximately \$1270 to the bursary on behalf of Mike Harnadek who had passed away.
